Code of Conduct

EU-India-BCE: Field Trip – Progress in Advanced Biofuels

Preamble

This Code of Conduct must be observed and respected during the whole Field Trip by all participants. The organisers, ETA Florence, retain the right to oblige a participant to leave the group in case of serious failure to respect the Code of Conduct at any point during the Field Trip. In such a case, the participant who failed to respect the Code of Conduct, would be entitled to no financial compensation and he will have to cover all costs at his/her own.

Tobacco / alcohol / drugs are not allowed in the coach and on-site visits. Alcohol, in low quantities, is allowed during dinner in restaurants. Tobacco/smoking is allowed during coach stops, outside of buildings, but at least 10 minutes before coach departure.

Covid 19 rules

- Participants are advised to have an insurance to cover incidence of Covid 19 illness. If
 needed to isolate due to Covid 19 sickness, ETA Florence bears no responsibility and
 can provide no financial support. In such a case the sick participant will have to leave
 the group and isolate at the place where the sickness was discovered. The sick
 participant will have to cover all related costs on his/her own.
- In the coach there will be enough place so that participants will be sitting alone. Use of protective masks is recommended. Please bring disinfectants and masks. You may be required to use them during a site visit.
- Our hosts have not requested any special measures. Please respect the general practices and note that local measures could be reinforced if necessary according sanitary situation at the site and the pandemic situation in October.

Accident insurance

• Although all efforts will be made by ETA Florence and the hosts, an accident can't be excluded. Therefore, you are advised to take an accident insurance for the whole trip in case you do not already have one. ETA Florence and the hosts bear no responsibility and can provide no financial support in case of an accident.

On site visits

- Please always stay with the group and with the Guide of the Hosts. Never wonder alone or unaccompanied around at any place during the site visits.
- Participants are advised to always follow the safety regulations of the Hosts.
 Personal Protective Equipment (PPE such as helmet, glasses, gloves, overall or jacket, trousers and security shoes) may have to be used at the site visits according to the instructions of the Hosts. Please travel light and it is recommended to wear trousers or long clothing and wear closed shoes with preferably non leather soles.

- Photographs are strictly prohibited. A professional photographer will accompany the Field Trip and he will take photos and videos under the guidance of the Hosts. The photos and videos will be shared with all participants and Hosts.
- Some of the Hosts will ask you to complete online requirements before you can
 enter their facilities. Please so diligently. Failure to follow such instructions may
 result in refusal to enter a facility in which case you will have to wait in the coach.
